Call to Order / Pledge of Allegiance / Roll Call

A special meeting of the Whiteford Agricultural School Board of Education was called to order at 5:30 p.m. by President Christine Bischoff on February 23, 2023. Approval of Agenda

Board Action – Student Discipline

Following the hearing, a motion was made by Mike lott, seconded by Janelle Young, that the Board finds that Student #2023-1 violated Section IV of the Student Code of Conduct and is suspended through the end of the 3rd marking period. Motion approved – 5 yes, 1 absent (Dixon), 1 abstain (Mock).

Approval of Three-Year Snow Removal Contract Extension

A motion was made by Shane Hillard, seconded by Jeff Bunge, to approve the three-year snow removal contract extension with MLS Property Maintenance (Steinman Family Services, LLC) as presented, for the 2023-2024, 2024-2025, and 2025-2026 snow seasons. Motion approved – 6 yes, 1 absent (Dixon).

Recommendation to Hire Middle School Assistant Track & Field Coach

A motion was made by Mike lott, seconded by Kristi Mock, to hire Kristin Thomas through EduStaff as the new Middle School Assistant Track & Field Coach at 4% of step 6 at \$1672.32, and contingent upon favorable previous employer and FBI/State of Michigan background checks. Motion approved – 6 yes, 1 absent (Dixon).

Recommendation to Hire High School Assistant Track & Field Coach

A motion was made by Mike lott, seconded by Janelle Young, to hire Jaycie Harris as the new High School Assistant Track & Field Coach at 4% of step 2 BA of the 2021-2023 WEA contract at \$1672.32. Motion approved – 6 yes, 1 absent (Dixon).
