#### December 12, 2022

A regular meeting of the Whiteford Agricultural School Board of Education was called to order at 6:15 p.m. by President Christine Bischoff on December 12, 2022. #### **Administrative Reports**

# Business Office - Mrs. Tebbe-Cousino

- Continuing Disclosure Report: This report was submitted to Baker Tilly (underwriter for district bonds) and includes annual financial information such as current and next year's projected pupil count, current and prior year state aid payments, current and prior year tax levies and collections, budget and budget adjustments, bargaining unit contracts, number of current employees, and a copy of the prior year audit. Baker Tilly file with EMMA and the state repository by December 31st each year.
- <u>Facility Settlement Report:</u> This report was submitted to the Monroe ISD, which gathers information
  from the SE4094 (medical staff costs report) and SE4096 (transportation for special education
  services report). These reports are used to determine the amount of reimbursement the district
  receives of costs of providing these services.
- Health Insurance Bids: Bids were collected via our broker Savage & Associates from Paramount, Blue Cross Blue Shield of Michigan and United Health. Paramount was a 7% increase, with the state only increasing the amount the employer has to pay by 1.5%; therefore, an effective 5.5% increase for staff. Bids from BC/BS and United Health had lower monthly premiums but their out-of-pocket maximums were much higher than Paramount's.
- <u>Pupil Accounting</u>: These packets and numbers (one from each of the three buildings) were verified
  and released to be submitted on time by the building offices.
- Mrs. Machcinski is doing a wonderful job having submitted the Registry of Educational Personnel (REP) by the 12/1 deadline; and is bringing HR functions up-to-date, having already distributed 2022-2023 teacher contracts, Open Enrollment documents for annual insurance changes, and reviewing personnel files to make sure they are compliant.
- The business office is looking ahead to <u>year-end tasks</u> (1099 reporting, 1095 Health Care reporting, W-2 reporting) and expanding the scope of responsibilities for Mrs. Cruz-Hartland to expand her role in accounting/cross training (i.e., bank recs, grant reporting, help with budgeting). To date, she has focused primarily on payroll.

## Elementary School - Mrs. Anderson

Principal Anderson shared the November 2022 attendance report for Whiteford Elementary and reported the following:

- Attendance was stable the week of Thanksgiving; however, there have been quite a few out sick since.
- OSU-UM Food Drive: OSU won the food drive; a total of 1,500 food items were donated to a local food pantry.
- NWEA Testing continues this week where students show what they know.

## Administrative Reports Continued...

- Professional Development on 12/2: 2 hours on conscious discipline and literacy was presented by inhouse presenters. The staff dialogue was positive and supportive as we learn more to best serve our students.
- Elementary Christmas Concert is Thursday, December 15 with K-2 beginning at 6pm and 3-5 starting at 7:15pm.
- Spirit Week is the Week of December 19-22!
- Bubba the Pony coming to the elementary school on December 22 to spread some holiday cheer to students and staff!
- Mariann Hillard is really making huge difference with her new role as Behavior Interventionist.

## Middle/High School - Mr. Fielder

Principal Fielder shared the November 2022 attendance report for Whiteford Middle and Whiteford High Schools and reported the following:

- Attendance is fluctuating as we are seeing quite a few students sick.
- Big win for football team state champions! ... community support was outstanding.
- NWEA testing for middle school students in grades 6-8 continues this week.
- Schoology/Infinite Campus integration process is occurring in hopes of allowing families to access as a one-stop-shop for parents to access grades.
- Josten's was here for cap and gown orders for seniors, and will be following up this Wednesday for students to place orders.
- A lot of questions with GoFan "no cash" ticketing system, but the feedback has been overwhelming in support of this change.
- John Basile (Student Assistance Coordinator/Monroe ISD) visited 7th and 8th grade students last week about vaping and drug use.
- State Honors Choir saw Dylan Anderson, Seamus Waterford, and Alena Ellis moving on to the next level of competition.

## Superintendent's Report

- <u>98c Learning Loss Plan</u> On July 14, 2022, Governor Gretchen Whitmer signed into law Public Act 144 of 2022. Section 98c (MCL 388.1698c) of the act appropriates \$52,056,000 in federal funding for local education agencies to address learning loss as part of the Governor's Emergency Education Relief (GEER) Fund and part of the Secondary School Emergency Relief (ESSER) Il Fund. The funds support goal 5 of Michigan's Top 10 Strategic Education Plan. You might recall that back in October, I presented to the Board of Education the <u>98c Learning Loss Grant Board Presentation October 2022</u> outlining possible uses of these funds. Whiteford Agricultural Schools will commit 98c funds to address learning loss among targeted student groups through the administration of high-quality, reliable assessments to assess and monitor student academic and behavior progress through the use of differentiated instruction that is provided in one-on-one or small group settings outlined in this plan: <u>98c Learning Loss Grant Plan</u>.
- <u>Winter Sports Coaches</u> Enclosed in your packet is a memo from Athletic Director, Jeremy Simmons, updating the board on winter coaching assignments.
