INTRODUCTIONS-WHO AND WHAT THE PURPOSE OF THE SAFETY COUNCIL?

The Safety Council is the primary school safety organizational team in the district. The team develops plans, and establishes protocols and procedures, organizes programs and services, provides information and support, receives ongoing training and updates and generally oversees the school safety activities in the district. They will set short and long-term safety goals. They may recommend to the Superintendent and/or BOE initiatives, training, and procedures to be implemented, purchases to be approved, and policies to be adopted. The Safety Council meets monthly as an extension of the Administrative Leadership Team.




I currently have a child(ren) at the following buildings?


Which of the following categories best describes your child(ren) enrollment circumstances?



On a scale of 1 to 5, how safe do you feel your child(ren) are at Whiteford Schools? 135 responses






Student/Staff Safety Survey Data






On a scale of 1 to 5, how safe do you feel at Whiteford Schools? 387 responses




